Rector's Order 3/2021 on in-class teaching and exams, and admission tests during the state of emergency at the University of Pécs

Based on Article 14 of the Government Decree 484/2020 (10 November) on the second phase of protective measures applicable during the state of emergency, the rector of the higher education institution may decide on in-class knowledge assessment (particularly those linked to practical training or those that require the students personal attendance) with that the relevant protective measures shall be complied with.

Based on this authorization outlined in the Government Decree 484/2020 (10 November) and on the initiative of the Faculties, I hereby stipulate the following provisions in connection with the in-class teaching, exams, and admission tests at the University of Pécs.

Article 1 (1) As a general rule, teaching and exams should be conducted digitally (online) at the University of Pécs (hereinafter: University) in the spring semester of the Academic Year 2020/2021 according to Annex 17 of UP's Code of Studies and Examinations (Annex 5 to the Statutes of UP, hereinafter: Code of Studies) on the special provisions during the coronavirus pandemic and the relevant Dean's Orders.

(2) I hereby allow in-class teaching and knowledge assessment activities at the Faculties and for the study programs listed in the Annex to this Order.

(3) The scope of this Order covers the students of the study programs listed in the Annex, the applicants to those study programs, the lecturers, and the administrative staff of these study programs.

(4) The material scope of the Order covers (as outlined in the Annex):

- a) classes (lectures, seminars, practices, consultations),
- b) exams,
- c) Final Exams,
- d) professional practices (internship),
- e) admission tests according to Article 18 of the Government Decree 423/2012 (29 December) on the provisions of higher education admission procedures and the relevant regulations of the University.

(5) The scope of the Order does not extend to doctoral studies, in the case of which the relevant regulations of the University and Article 11 of the Joint Order No. 20/2020 of the Rector and the Chancellor on the order of entering the premises of the University during the state of emergency shall continue to apply.

Article 2 I hereby authorize the UP Operative Crew to outline the minimal requirements for the protective measures to be applied during in-class teaching, exams, and admission tests.

Article 3 This Order enters into force on 10 May 2021.
