

Information about the closing of the rotational year

1. Procedure of recognising student volunteer work in the practical training

- Recognition of student volunteer work is regulated by Dean's Order no. 2/2020 (April 6).
- Student volunteer patient-care work can be recognised as professional practice fully or partially with the approval of the competent course director to the extent of his/her decision.
- Decision about the recognition is required both in case of volunteer work completed in- as well as outside of the University.
- Due to the epidemiological situation, certificates shall be delivered electronically from the side of all parties involved.



3. Final closing examinations during the coronavirus epidemic

- Based on Article 13 of the Government decree No. 101/2020 (04.10.) higher educational institutions can organize the final closing examination for students with personal presence. Based on this, students can enter the premises of higher educational institutions for the duration of the final closing examination. Rotational year students of the UPMS will have the possibility to take the final closing examinations with personal presence by attending the exams in person, this won't be possible by distant education.
- To be able to determine the exact number of students (for both the written and the oral final closing examinations) every student must apply through the MeetStreet system depending on which final exam period they wish to take the exam in. The application surface for the June final closing examination period will be available between May 11 and May 22, 2020.
- Taking an exam with personal attendance will be possible by strict adherence to the rules and procedures of infectology in accordance with the resolution No. 08/2020. (04.24.) of the Operative Crew
- Before starting the exam, the student certifies with his/her signature that he/ she is asymptomatic and has no complaints and has not been in contact with a confirmed or suspected coronavirus-infected patient or even so, then it has happened in the protection of properly worn personal protective equipment. This must be done by filling out the attached form with the title "Student's statement about the involvement of the COVID-19 pandemic".
- Having the conditions fulfilled for taking an exam (including the health status) shall be checked by the examiner or the supervising teacher under his/her authority before the exam. After each use of the equipment related to the examination, the equipment must be disinfected with short exposure time. Hand disinfection is recommended for the examiner before and after the use of the equipment.
- The protective equipment for students, who are taking the exam is provided centrally by the Faculty. Medical students must wear a surgical mask and gloves at all times during the practice or the practical exam (droplet isolation).
